Pregnancy and Women's Substance Use Disorder: Focus on Opioid Use Disorder Treatment Strategies

Program Director – Ventura County Medical Center
Primary Care Addiction Medicine Fellowship

This presentation will examine various addictive substances and their effects on pregnant women and the fetus. Dr. Kahn's lecture will provide insights into medication-assisted treatment and the effects of withdrawal during pregnancy. Guidelines for breastfeeding and substance use or substance use disorder will also be reviewed.

LEARNING OBJECTIVES:

- Describe the unique physiology of Substance Use Disorder (SUD) in pregnancy.
- Evaluate the different modalities for starting medication-assisted treatment (MAT) in the day of high dose fentanyl.
- Identify breastfeeding recommendations for mother-baby dyads.

DR. TIPU KHAN is a Family Physician and Addiction Specialist. He is the Chief of Addictive Medicine (ADM) at Ventura County Medical Center, Fellowship Director of the ADM fellowship program, and core faculty with the Family Medicine Residency Program. He is the Southern California Addiction Medicine Medical Director for HealthRIGHT 360 Prototypes. Dr. Khan is an Adjunct Clinical Professor at USC Keck School of Medicine.
