The **New Frontier** of **Psychedelic Therapies** in Psychiatry

This presentation will provide information about new therapeutics in mental health treatment by using psychedelic agents. These agents have a complicated history, including their use in religious and healing ceremonies over many centuries. Since the discovery of LSD in 1946, early research in the middle of the last century was halted in the 1960s for the next 40 years.

Since 2000, new research has provided evidence that these agents have longlasting efficacy in treating some of the most severe and difficult to treat mental health and substance abuse disorders, including PTSD, treatment-resistant depression, alcohol use disorder and other uses.

These medications provide a consciousness-changing experience, and the idea of using them therapeutically causes a wide variety of reactions and perspectives in our society. Investigations now are looking at benefits these medicines can provide, which approaches to treatment work best, and potential risks of harm. Government and societal institutions are considering policies and guidelines if these medicines become FDA approved.

In this course participants will learn what psychedelic agents are, how they've been used historically, what new research is showing, how treatment is structured, hypotheses about how they work and ideas about what the future holds for psychedelic therapeutics.

PAUL ERICKSON, MD, has been the Medical Director of Psychiatry and Addiction Medicine Services at Santa Barbara Cottage Hospital since 2002. Prior to that he was the Clinical Director of Services in the Department of Psychiatry at the Cambridge Hospital, Harvard Medical School. Dr. Erickson graduated cum laude from Yale University and received his MD from the University of Massachusetts Medical School. He is board certified in Addiction Medicine. Dr. Erickson created and led the Medical School clerkship in Psychiatry for USC Medical students. One of his most recent community leadership roles is as the developer of the Bridge Clinic with Santa Barbara Neighborhood Clinics.
