# More Fire than Water: Understanding Adult ADHD

The natural history of adults with ADHD shows profound impairments throughout adult life, but until recently ADHD in adults was invisible. Adults with ADHD have poorer academic functioning, more frequent loss of jobs and marriages, more traffic accidents and arrests, poor self-care, poorer health outcomes, increased rates of suicide, and other severe life consequences. Given these impacts, why is there so little recognition of and treatment of ADHD in adults?

This presentation will review the complex history of ADHD diagnosis. The criteria for an ADHD diagnosis in adults in DSM 5 recognize that the symptom presentation may be different, and that the effects on functioning in life are different. Diagnostic criteria require fewer symptoms; onset before age 12 (previously age 7 for childhood diagnosis); and evidence of *interference* with functioning, not *impairment* as previously believed.

We will also look at the evidence for genetic and brain imaging differences between adults with ADHD and without ADHD. We will review the natural history of untreated ADHD in adults, the most effective treatments, and treatment controversies.

Finally we will review the small number of studies that have looked at long term treatment of ADHD in adults and see if treatment can make a difference in the quality of life and functioning for adults with ADHD.

**PAUL ERICKSON, MD,** has been the Medical Director of Psychiatry and Addiction Medicine Services at Santa Barbara Cottage Hospital since 2002. Prior to that he was the Clinical Director of Services in the Department of Psychiatry at the Cambridge Hospital, Harvard Medical School. Dr. Erickson graduated cum laude from Yale University and received his MD from the University of Massachusetts Medical School. He is board certified in Addiction Medicine. Dr. Erickson created and leads the Medical School clerkship in Psychiatry for USC Medical students. One of his most recent community leadership roles was as the developer of the Bridge Clinic with Santa Barbara Neighborhood Clinics.
